To Whom It May Concern:

Pursuant to exemption No. C2021-25 (Passengers on flight from Myanmar to Canada – Pre-arrival COVID-19 Molecular Test), the individual identified below is authorized to board a flight from Myanmar to Canada without providing evidence of a COVID-19 molecular test. This exemption was granted by an authorized official of Transport Canada pursuant to the *Aeronautics Act*. This letter does not exempt the identified traveller(s) from either: public health measures that may be required upon arrival in Canada; or any border entry/admissibility requirements. It should be noted that, given the evolving nature of the global pandemic, local authorities may impose control measures suddenly, including movement restrictions, at any time.

Individuals entering Canada need to follow testing and quarantine requirements to keep Canadians safe, particularly given the new COVID-19 variants in Canada and around the world. Upon arrival in Canada:

- Have your ArriveCAN receipt, hotel booking and quarantine plans ready for assessment by a Border Services Officer
- Take a COVID-19 molecular test upon arrival (day 1) and on day 10 of your 14-day quarantine period
- Go directly to your pre-booked hotel for up to 3-nights to await results from your arrival test
- Follow any other direction provided by a Quarantine Officer including, but not limited to, being transferred to a Designated Quarantine Facility (DQF)

Section 3: Privacy and Information Sharing

The information provided on this form is protected by the *Privacy Act*. The undersigned acknowledges they understand that the information collected on this form will be shared with Transport Canada, the Canada Border Services Agency, and the Public Health Agency of Canada for public health purposes and to facilitate compliance with the *Quarantine Act* and the *Aeronautics Act*.

Section 4: Requirements under the Transport Canada *Interim Order Respecting Certain Requirements for Civil Aviation Due to COVID-19*

The individual traveller(s) are still subject to all other interim order requirements that may apply, including:

1. The individual cannot travel if they have COVID-19 or suspect to have COVID-19;
2. The individual cannot travel if they have a fever and a cough or a fever and breathing difficulties, unless they provide a medical certificate certifying that their symptoms are not related to COVID-19.
3. The individual cannot travel if they have been denied permission to board an aircraft in the previous 14 days for medical reasons related to COVID-19;
4. The individual must comply with all other health check questions, temperature screening requirements at the airport and face mask requirements while in the airport and while in transit.

Section 5: Confirmation and Acknowledgement by Traveller

- (1) The exemption from the requirement to provide evidence of a pre-departure COVID-19 molecular test under the *Interim Order Respecting Certain Requirements for Civil Aviation due to COVID-19* is for a set duration as indicated under the Effective Period section below.
- (2) The requirement to provide evidence of a result for a COVID-19 molecular test is required to protect the safety of the public in general, other travellers, and crew by minimizing the risk of spreading COVID-19;
- (3) I hereby undertake to comply with any and all applicable public health measures required of me upon arrival in Canada, to minimize the risk of spreading COVID-19.

Section 6: Confirmation on Behalf of another Person

This section must be filled out only if the person subject to this exemption is a child between the ages of five (5) and 15 years inclusively, or if the person is not a competent adult. Travellers 16 years of age and older must sign their own form.

The undersigned, being the parent, legal guardian, the person authorized by the parent or legal guardian to travel with the person(s) identified in Section 1, hereby confirms that they acknowledge, on behalf of that person, the information set out above in section 5 – clauses 1 to 4.

Section 7: Instructions

The traveller is required to present this letter to the Canada Border Services Agency (CBSA) and/or the Public Health Agency of Canada (PHAC) upon arrival in Canada. Violating any instructions provided when entering Canada or failing to provide accurate information is an offence under the Quarantine Act and could lead to up to 6 months in prison and/or \$750,000 in fines.

Effective Period:

This letter is valid for flights routing to Canada without interruption, as specified within (Section 2). This letter will not be valid beyond the expiry date of exemption NO. C2021-25 (23:59 P.M. EST on April 22, 2021).
